The motion carried with a vote of 3-0. J. Price made a motion to appoint Vicki Peerman as the secretary of Finance Board; R. Thornburg seconded. The motion carried with a vote of 3-0.

- C. Schmitz stated this agreement is with the Workforce Investment Board to take Carl Schmitz off the Board and replace with Randy Thornburg.
- R. Thornburg made a motion to sign the Local Elected Officials Agreement; J. Price seconded. The motion carried with a vote of 3-0.

# **BOARD APPOINTMENTS**

Visit Posey County: J. Price made a motion to appoint Kay Kilgore to the Visit Posey County Board for a one-year term expiring on 12/31/2019; R. Thornburg seconded. The motion carried with a vote of 3-0.

E911 Director: J. Price made a motion to appoint Jason Knowles as the E911 Director for Posey County; R. Thornburg seconded. The motion carried with a vote of 3-0.

Posey County Economic Development Partnership: C. Schmitz stated after some investigating it was discovered a Commissioner would have to sit on this Board and could not be a designee. C. Schmitz stated he would sit on this Board.

#### **HEALTH DEPARTMENT BUILDING**

C. Schmitz stated Jim Alsop opened bids for the remodel of the new Health Department Building. Mr. Schmitz stated they received three bids with Greenwell being the lowest bid at \$149,750.00. R. Thornburg made a motion to accept this bid; J. Price seconded. C. Schmitz stated the funding would come from Cum Capital and the Health Department would be funding \$25,000.00 of the remodel.

#### MT. VERNON GARDEN CLUB

Gayle Vogel with the Mt. Vernon Garden Club expressed their gratitude for the Commissioners on their ongoing partnership to keep the Courthouse square and surrounding gardens maintained.

# SHERIFF DEPARTMENT CREDIT CARD REQUEST

Posey County Sheriff, Tom Latham is requesting permission for his department to obtain a credit card to aid in the purchase necessities for that department. Mr. Latham stated they would need three separate cards that are all linked to the same account. R. Thornburg made a motion to approve this request; J. Price seconded. C. Schmitz asked that Mr. Latham let the Auditors office know who will be authorized to use the cards. The motion carried with a vote of 3-0.

Mr. Latham stated the Jail is housing 103 inmates as of today; with 60 of those inmates being housed for Vanderburgh County. Mr. Latham stated the department took in \$63,000.00 in December from the DOC and Vanderburgh County.

## **DEPARTMENT UPDATE**

Steve Schenk, with the Posey County Highway Department, explained the funds that are invested with the Treasurer is money that will be used to pay back a \$1,000,000.00 loan from the State. Mr. Schenk stated this is for the Distressed Road Fund program that gives Counties \$1,000,000.00 interest free that must be paid back in ten years. Mr. Schenk stated at the end of the ten years, the County pays back the \$1,000,000.00 and keeps the interest.

Larry Robb, Posey Count EMA, stated the rivers will be rising but foresees no major flooding issues.

Randy Thornburg stated the Sewer Board is moving into the building phase of their project. Mr. Thornburg stated the issue of fees involved with inspections was brought to the Boards attention. Mr. Thornburg stated the Sewer Board would be incurring inspection fees from the County for their building project. R. Thornburg made a motion to wave inspection fees for this project; J. Price seconded. The motion carried with a vote of 3-0.

No further business was discussed and the meeting was adjourned.
