POSEY COUNTY COMMISSIONERS TUESDAY JANUARY 8TH, 2019

The Posey County Commissioners met in regular session at the Hovey House on Tuesday, January 8th, 2019 at 9:00 a.m. The following members were present at said meeting: Commissioner Carl Schmitz, Commissioner Jay Price, and Commissioner Randy Thornburg. Auditor Sarah Beth Meighen and Commissioner Attorney Joseph Harrison.

C. Schmitz called the Posey County Commissioners Meeting to order at 9:00 a.m. with the Pledge of Allegiance.

OFFICER ELECTIONS

Commissioner President:

R. Thornburg made a motion to elect Carl Schmitz to the Commissioner President position; J. Price seconded. The motion carried with a vote of 3-0.

Commissioner Vice President:

C. Schmitz made a motion to elect Randy Thornburg to the Commissioner Vice President position; J. Price seconded. The motion carried with a vote of 3-0.

COMMISSIONER ATTORNEY APPOINTMENT

C. Schmitz made a motion to appoint Joseph Harrison as the Commissioner attorney for 2019; R. Thornburg seconded. The motion carried with a vote of 3-0.

MINUTES

David Whitten, Posey County Election Board Member, addressed the Commissioners in reference to the use of the Commissioner's Room at the Hovey House on the Monday, Tuesday and Wednesday of the Election weeks. Mr. Whitten stated the Board stores voting machines in the meeting room and must transport those out on Monday, and back in on Wednesday. He asked the Commissioners to take that into consideration when scheduling their meetings for next year.

Mr. Whitten explained if the Municipal Election would be held during the County Election cycle, there would be savings of \$75,000.00. Mr. Whitten stated the Election Board is asking the Commissioners to consider meeting with City Council to see if they would consider holding Municipal Elections during General Elections for a cost saving measure.
