POSEY COUNTY COUNCIL TUESDAY FEBRUARY 11TH, 2020

The Posey County Council met in regular session at the Hovey House on Tuesday, February 11th, 2020 at 9:00am. The following members were present at said meeting: Heather Allyn, Stefani Miller, Tom Schneider, Marilyn Brenton, Dave Pearce, Aaron Wilson; County Attorney Joe Harrison; and Auditor, Maegen Greenwell. Council member Robert Gentil was absent.

H. Allyn called the Posey County Council meeting to order at 9:00am with the Pledge of Allegiance and Pastor Naal said an opening prayer.

MINUTES

- H. Allyn stated there were a few changes to be made; Commissioner Attorney needs to read County Attorney and Broadband was misspelled.
- D. Pearce made a motion to approve the minutes with those changes; M. Brenton seconded. The motion carried with a vote of 6-0.

TREASURER'S REPORT

S. Miller made a motion to approve the January Treasurer's Report; A. Wilson seconded. The motion carried with a vote of 6-0.

ADDITIONAL APPROPRATION REQUEST

Thomas Clowers, Posey County Prosecutor, is requesting four additional appropriations to the Prosecutors Federal Forfeiture Fund. Mr. Clowers explained these were left out of the appropriation process at budget time. Mr. Clowers stated the request includes the following: \$1500.00 for the training line

\$500.00 for the supplies line

\$2000.00 for the task force line

\$1000.00 for the equipment line

M. Brenton made a motion to approve these requests; T. Schneider seconded. The motion carried with a vote of 6-0.

Mr. Clowers is requesting an additional appropriation to the Infraction Deferral fund in the amount of \$15,000.00. Mr. Clowers explained this is needed to cover part time pay in 2020 for a case that was carried over from 2019.

A. Wilson made a motion to approve this request; S. Miller seconded. The motion carried with a vote of 6-0.

Posey County Sheriff, Tom Latham, is requesting an additional appropriation to the Public Safety fund in the amount of \$6,395.00. Mr. Latham stated this will fund the increase of the Chief Deputy salary that was approved at the January Council meeting.

S. Miller made a motion to approve this request; A. Wilson seconded. The motion carried with a vote of 6-0.

Sheriff Latham updated the Council with the following jail numbers:

132 total inmates

56- Vanderburgh County

11- DOC

65- Posey County

\$62,090.00 was paid from Vanderburgh County in January.

Posey County Auditor, Maegen Greenwell, is speaking for the Posey County Clerk and requesting two additional appropriations to the Clerks Record Preservation Fund. Mrs. Greenwell stated this fund was not appropriated at budget time. Mrs. Greenwell stated the request is for \$84,000.00 to the preservation line and \$500.00 to the miscellaneous line. A. Wilson made a motion to approve these request; M. Brenton seconded. The motion carried with a vote of 6-0.

Cheryl Reich, with the Posey County Health Department, is requesting an additional appropriation in the amount of \$24,5000.00 for the Health Board Fund. Mrs. Reich stated this will be used for the new Receptionist position that was approved at the January Council meeting. D. Pearce made a motion to approve this request; S. Miller seconded. The motion carried with a vote of 6-0.

Cheryl Reich, with the Posey County Health Department, is requesting an additional appropriation in the amount of \$14,000.00 for the Health Board Fund. Mrs. Reich stated this will be used for the new Nurse Assistant position that was approved at the January Council meeting. T. Schneider made a motion to approve this request; A. Wilson seconded. The motion carried with a vote of 6-0.

H. Allyn informed the Council of a few upcoming expenses that would need to be funded. Mrs. Allyn stated the Sheriff will be replacing the roof on the administrative building of the jail; and the Courthouse roof and dome will be in need of repair soon.

No further business was discussed.

D. Pearce made a motion to adjourn; A. Wilson seconded. The motion carried with a vote of 6-0.
