

POSEY COUNTY COUNCIL TUESDAY JUNE 11TH, 2019

The Posey County Council met in regular session at the Hovey House on Tuesday, June 11th, 2019 at 9:00am. The following members were present at said meeting: Heather Allyn, Stefani Miller, Dave Pearce, Robert Gentil, Tom Schneider and Aaron Wilson; Council Attorney William Bender; and Auditor, Sarah Beth Meighen. Council member Marilyn Brenton was absent.

H. Allyn called the Posey County Council meeting to order at 9:00am with the Pledge of Allegiance.

MINUTES

D. Pearce made a motion to approve the May Council minutes; S. Miller seconded. The motion carried with a vote of 6-0.

TREASURER'S REPORT

S. Miller made a motion to approve the May Treasurer's report; D. Pearce seconded. The motion carried with a vote of 6-0.

CLERK'S REPORT

R. Gentil made a motion to approve the March Clerk's report; A. Wilson seconded. The motion carried with a vote of 6-0.

S. Miller made a motion to approve the April Clerk's report; D. Pearce seconded. The motion carried with a vote of 6-0.

ADDITIONAL APPROPRIATION REQUEST

Steve Schenk, Posey County Highway Superintendent, is requesting an additional appropriation in the amount of \$80,264.97. Mr. Schenk stated this is the 80% of the County's portion that was paid by the State for the County Bridge Inspection. Mr. Schenk stated the County pays an initial 20% up front and the State sends back 80% of the total.

T. Schneider made a motion to approve this request; A. Wilson seconded. The motion carried with a vote of 6-0.


Judge Goedde, Posey County Circuit Court Judge, is requesting two additional appropriations; one in the amount of \$1000.00 for Judge travel, and one in the amount of \$ 68,000.00 for Guardian Ad Litem fund. Judge Goedde stated the current balance of the Guardian Ad Litem account is \$ 214.17 and they are holding on \$23,268.66 in claims to be paid.

Judge Goedde explained to the Council, he and Judge Clowers have implemented a claim pay schedule with the attorneys that practice within their courts. Judge Goedde explained he hopes this will cut down on the length of time claims are held by attorneys and will allow claims to be paid from the appropriate budget cycle.


A. Wilson made a motion to approve this request; S. Miller seconded. The motion carried with a vote of 6-0.

Posey County Sheriff, Tom Latham, informed the Council the jail is currently housing 118 inmates; 48 of those are Vanderburgh County, 11 of those are Sullivan County, and 59 are Posey County. Sheriff Latham stated in May the jail took in \$76,000.00 from Sullivan County and Vanderburgh County.

No further business was discussed and the meeting was adjourned.
