ORDINANCE NO. 2021 - 03-02-01

AN ORDINANCE AMENDING CHAPTER 153 OF THE POSEY COUNTY ZONING CODE

WHEREAS, the Board of Commissioners of Posey County, Indiana, as the executive and legislative body of Posey County, has the power to adopt and amend ordinances relating to the administration of Posey County government; and

WHEREAS, the Board of Commissioners of Posey County now seek to amend Chapter 153 of the Posey County Zoning Code.

NOW THEREFORE, BE IT ORDAINED by the Board of Commissioners of Posey County, Indiana, as follows:

SECTION 1. AMENDMENT TO SECTION 153.134.02 E. OF THE POSEY COUNTY ZONING CODE

The chart included in Section 153.134.02 E. of the Posey County Zoning Code is hereby amended (as highlighted), to read as follows:
