Mr. Fortune stated the Jail is now down to four jailers.

Posey County Highway representative, Jeff Toelle, addressed the Commissioners regarding the need to seek reimbursement from German Township Water for the repairs done on Buchanan Road due to a pipe malfunction. Mr. Toelle asked that the Commissioners request for reimbursement also include a request to permanently fix this issue, as it is reoccurring and that road is on the list to be blacktopped next year.

Posey County EMA Director, Larry Robb, informed the Commissioners there is currently minor flooding in the County, and roads that are affected have signs posted. Mr. Robb stated his department is working on new ID cards for County employees. Mr. Robb stated the emergency siren at St. Phillip School is not working and will be \$4,500.00 to repair.
